YOUR VOTE IS IMPORTANT

The business of the Annual General Meeting affects your shareholding and your vote is important.

VOTING ELIGIBILITY

The Directors have determined pursuant to Regulation 7.11.37 of the Corporations Regulations 2001 (Cth) that the persons eligible to vote at the Annual General Meeting are those who are registered Shareholders at 9am (WST) on 21 November 2011.

VOTING IN PERSON

To vote in person, attend the Annual General Meeting at the time, date and place set out above.

VOTING BY PROXY

To vote by proxy, please complete and sign the enclosed Proxy Form and return by the time and in accordance with the instructions set out on the Proxy Form.

New sections 250BB and 250BC of the Corporations Act came into effect on 1 August 2011 and apply to voting by proxy on or after that date. Shareholders and their proxies should be aware of these changes to the Corporations Act, as they will apply to this Annual General Meeting. Broadly, the changes mean that:

- if proxy holders vote, they must cast all directed proxies as directed; and

- any directed proxies which are not voted will automatically default to the Chair, who must vote the proxies as directed.

Further details on these changes is set out below.

Proxy vote if appointment specifies way to vote

Section 250BB(1) of the Corporations Act provides that an appointment of a proxy may specify the way the proxy is to vote on a particular resolution and, **if it does**:

- the proxy need not vote on a show of hands, but if the proxy does so, the proxy must vote that way (i.e. as directed); and
- if the proxy has 2 or more appointments that specify different ways to vote on the resolution – the proxy must not vote on a show of hands; and
- if the proxy is the chair of the meeting at which the resolution is voted on – the proxy must vote on a poll, and must vote that way (i.e. as directed); and
- if the proxy is not the chair – the proxy need not vote on the poll, but if the proxy does so, the proxy must vote that way (i.e. as directed).

Transfer of non-chair proxy to chair in certain circumstances

Section 250BC of the Corporations Act provides that, if:

- an appointment of a proxy specifies the way the proxy is to vote on a particular resolution at a meeting of the Company's members; and
- the appointed proxy is not the chair of the meeting; and
- at the meeting, a poll is duly demanded on the resolution; and
- either of the following applies:
 - the proxy is not recorded as attending the meeting;
 - the proxy does not vote on the resolution,

the chair of the meeting is taken, before voting on the resolution closes, to have been appointed as the proxy for the purposes of voting on the resolution at the meeting.

1. RESOLUTION 1 – ADOPTION OF REMUNERATION REPORT

To consider and, if thought fit, to pass, with or without amendment, the following resolution as a **non-binding resolution**:

“That, for the purpose of Section 250R(2) of the Corporations Act and for all other purposes, approval is given for the adoption of the Remuneration Report as contained in the Company's annual financial report for the financial year ended 30 June 2011.”

Note: the vote on this Resolution is advisory only and does not bind the Directors or the Company.

Voting Prohibition Statement:

A vote on this Resolution must not be cast (in any capacity) by or on behalf of any of the following persons:

- (a) *a member of the Key Management Personnel, details of whose remuneration are included in the Remuneration Report; or*
- (b) *a Closely Related Party of such a member.*

However, a person described above may vote on this Resolution if:

- (c) *the person does so as a proxy appointed by writing that specifies how the proxy is to vote on the Resolution; and*
- (d) *the vote is not cast on behalf of a person described in sub-paragraphs (a) or (b) above.*

2. RESOLUTION 2 – RE-ELECTION OF DIRECTOR – MR SIAS ELS

To consider and, if thought fit, to pass, with or without amendment, the following resolution as an **ordinary resolution**:

“That, for the purpose of clause 11.3 of the Constitution and for all other purposes, Mr Sias Els, a Director, who was appointed on 12 April 2010, retires by rotation, and being eligible, is re-elected as a Director.”

3. RESOLUTION 3 – RE-ELECTION OF DIRECTOR – MR TONY POLGLASE

“That, for the purposes of section 208 of the Corporations Act and ASX Listing Rule 10.14 and for all other purposes, approval is given for the Company to allot and issue 3,925,000 options to Mr Hugh Bresser pursuant to the Company’s Incentive Option Scheme on the terms and conditions set out in the Explanatory Statement.”

Voting Exclusion: The Company will disregard any votes cast on this resolution by a Director (except one who is ineligible to participate in any employee incentive scheme in relation to the Company) and any associates of those persons. However, the Company need not disregard a vote if it is cast by a person as a proxy for a person who is entitled to vote, in accordance with the directions on the Proxy Form, or it is cast by the person chairing the meeting as proxy for a person who is entitled to vote, in accordance with a direction on the Proxy Form to vote as the proxy decides.

Voting Prohibition Statement:

A person appointed as a proxy must not vote, on the basis of that appointment, on this Resolution if:

- (a) *the proxy is either:*

Voting Exclusion: The Company will disregard any votes cast on this resolution by a Director (except one who is ineligible to participate in any employee incentive scheme in relation to the Company) and any associates of those persons. However, the Company need not disregard a vote if it is cast by a person as a proxy for a person who is entitled to vote, in accordance with the directions on the Proxy Form, or it is cast by the person chairing the meeting as proxy for a person who is entitled to vote, in accordance with a direction on the Proxy Form to vote as the proxy decides.

Voting Prohibition Statement:

Company need not disregard a vote if it is cast by a person as a proxy for a person who is entitled to vote, in accordance with the directions on the Proxy Form, or it is cast by the person chairing the meeting as proxy for a person who is entitled to vote, in accordance with a direction on the Proxy Form to vote as the proxy decides.

EXPLANATORY STATEMENT

This Explanatory Statement has been prepared to provide information which the Directors believe to be material to Shareholders in deciding whether or not to pass the Resolutions which are the subject of the business of the Meeting.

1. FINANCIAL STATEMENTS AND REPORTS

In accordance with the Constitution, the business of the Meeting will include receipt and consideration of the annual financial report of the Company for the financial year ended 30 June 2011 together with the declaration of the directors, the directors' report, the remuneration report and the auditor's report.

The Company will not provide a hard copy of the Company's annual financial report to Shareholders unless specifically requested to do so. The Company's annual financial report is available on its website at <http://www.overlandresources.com>.

2. RESOLUTION 1 – ADOPTION OF REMUNERATION REPORT

2.1 General

The Corporations Act requires that at a listed company's annual general meeting, a resolution that the remuneration report be adopted must be put to the shareholders. However, such a resolution is advisory only and does not bind the Directors or the Company.

Under recent changes to the Corporations Act which came into effect on 1 July 2011, if at least 25% of the votes cast on Resolution 1 are voted against adoption of the Remuneration Report at the Annual General Meeting, and then again at the Company's 2012 annual general meeting, the Company will be required to put to Shareholders a resolution proposing the calling of an general meeting to consider the appointment of directors of the Company (**Spill Resolution**).

If more than 50% of Shareholders vote in favour of the Spill Resolution, the Company must convene the general meeting (**Spill Meeting**) within 90 days of the Company's 2012 annual general meeting. All of the Directors who were in office when the Company's 2012 Directors' report was approved, other than the managing director of the Company, will cease to hold office immediately before the end of the Spill Meeting but may stand for re-election at the Spill Meeting. Following the Spill Meeting those persons whose election or re-election as Directors is approved will be the Directors of the Company.

The remuneration report sets out the Company's remuneration arrangements for the Directors and senior management of the Company. The remuneration report is part of the Directors' report contained in the annual financial report of the Company for the financial year ending 30 June 2011.

A reasonable opportunity will be provided for discussion of the remuneration report at the Annual General Meeting.

2.2 Proxy Restrictions

Pursuant to the Corporations Act, if you elect to appoint the Chair, or another member of Key Management Personnel whose remuneration details are included in the Remuneration Report or any Closely Related Party of that member as your proxy to vote on this Resolution 1, *you must direct the proxy how*

they are to vote. Where you do not direct the Chair, or another member of Key Management Personnel whose remuneration details are included in the Remuneration Report or Closely Related Party of that member on how to vote on this Resolution 1, the proxy is prevented by the Corporations Act from exercising your vote and your vote will not be counted in relation to this Resolution 1.

2.3 Definitions

Key Management Personnel has the same meaning as in the accounting standards and broadly includes those persons having authority and responsibility for planning, directing and controlling the activities of the Company, directly or indirectly, including any director (whether executive or otherwise) of the Company.

Closely Related Party of a member of the Key Management Personnel means:

- (a) a spouse or child of the member;
- (b) a child of the member's spouse;
- (c) a dependent of the member or the member's spouse;
- (d) anyone else who is one of the member's family and may be expected to influence the member, or be influenced by the member, in the member's dealing with the entity;
- (e) a company the member controls; or
- (f) a person prescribed by the *Corporations Regulations 2001 (Cth)*.

Remuneration Report means the remuneration report set out in the Director's report section of the Company's annual financial report for the year ended 30 June 2011.

3. RESOLUTIONS 2 TO 3 – RE-ELECTION OF DIRECTORS – SIAS ELS AND TONY POLGLASE

Clause 11.3 of the Constitution requires that at the Company's annual general meeting in every year, one-third of the Directors for the time being, or, if their number is not a multiple of 3, then the number nearest one-third (rounded upwards in case of doubt), shall retire from office, provided always that no Director (except a Managing Director) shall hold office for a period in excess of 3 years, or until the third annual general meeting following his or her appointment, whichever is the longer, without submitting himself or herself for re-election.

The Directors to retire at an annual general meeting are those who have been longest in office since their last election, but, as between persons who became Directors on the same day, those to retire shall (unless they otherwise agree among themselves) be determined by drawing lots.

A Director who retires by rotation under clause 11.3 of the Constitution is eligible for re-election.

The Company currently has five Directors and accordingly two must retire.

4. RESOLUTION 4 – RATIFICATION OF PRIOR ISSUE – OPTIONS

4.1 General

On or about 13 January 2011, the Company issued a total of 700,000 Options to Nicholas Day, Beverley Nichols and Ming Jang. The Options were issued and allocated as follows:

Resolution 4 seeks Shareholder ratification pursuant to ASX Listing Rule 7.4 for the issue of those Options (**Ratification**).

The terms of the Options are set out in Schedule 1.

ASX Listing Rule 7.1 provides that a company must not, subject to specified exceptions, issue or agree to issue more equity securities during any 12 month period than that amount which represents 15% of the number of fully paid ordinary securities on issue at the commencement of that 12 month period.

ASX Listing Rule 7.4 sets out an exception to ASX Listing Rule 7.1. It provides that where a company in general meeting ratifies the previous issue of securities made pursuant to ASX Listing Rule 7.1 (and provided that the previous issue did not breach ASX Listing Rule 7.1) those securities will be deemed to have been made with shareholder approval for the purpose of ASX Listing Rule 7.1.

By ratifying this issue, the Company will retain the flexibility to issue equity securities in the future up to the 15% annual placement capacity set out in ASX Listing Rule 7.1 without the requirement to obtain prior Shareholder approval.

4.2 Technical information required by ASX Listing Rule 7.4

Pursuant to and in accordance with ASX Listing Rule 7.5, the following information is provided in relation to the Ratification:

- (a) 700,000 Options were allotted to Messrs Day, Nichols and Jang in consideration for consultancy services provided to the Company;
- (b) the Options were issued for nil cash consideration to Nicholas Day, Beverley Nichols and Ming Jang;
- (c) the Options were issued on the terms and conditions set out in Schedule 1;
- (d) the Options were allotted and issued to Nicholas Day, Beverley Nichols and Ming Jang, who are not related parties of the Company; and

- (e) no funds were raised from this issue as the Options were issued for nil cash consideration.

5. RESOLUTIONS 5 TO 8 – APPROVAL FOR ISSUE OF OPTIONS TO DIRECTORS

5.1 General

It is proposed that the following Options will be issued to Directors pursuant to the Company's Incentive Option Scheme (**Scheme**):

- (a) Mr Hugh Bresser (or his nominee) – 3,925,000 Options;
- (b) Mr Michael Haynes (or his nominee) – 1,925,000 Options;
- (c) Mr Gibson Pierce (or his nominee) – 1,925,000 Options; and
- (d) Mr Sias Els (or his nominee) – 1,925,000 Options (together the **Related Parties**).

A summary of the principal terms of the Options is set out in section 5.3. The full terms of the Scheme are attached at Schedule 2.

The purpose of the issue of the Options to the Related Parties is to motivate and reward them for their performance and as an incentive to participate in the Company's future growth.

5.2 Requirement for Shareholder Approval

The grant of the Options to the Related Parties pursuant to Resolutions 5, 6, 7 and 8 is an issue of securities to directors under an employee incentive scheme and consequently shareholder approval is required for the purposes of ASX Listing Rule 10.14.

For a public company, or an entity that the public company controls, to give a financial benefit to a related party of the public company, the public company or entity must:

- (f) obtain the approval of the public company's members in the manner set out in Sections 217 to 227 of the Corporations Act; and
- (g) give the benefit within 15 months following such approval,

unless the giving of the financial benefit falls within an exception set out in Sections 210 to 216 of the Corporations Act.

It is the view of the Directors that the exceptions set out in Sections 210 to 216 of the Corporations Act do not apply in the current circumstances. Accordingly, Shareholder approval is sought for the grant of Options to the Related Parties.

5.3 Principal terms of the Options

It is proposed that the related parties be issued with the following:

- (a) Mr Hugh Bresser (or his nominee) – 3,925,000 Options;
- (b) Mr Michael Haynes (or his nominee) – 1,925,000 Options;
- (c) Mr Gibson Pierce (or his nominee) – 1,925,000 Options; and

- (d) Mr Sias Els (or his nominee) – 1,925,000 Options.

The Options will be issued for nil cash consideration and will be exercisable at \$0.25 each expiring on or before the date which is five (5) years from the date of issue. 50% of the Options will vest immediately, whilst the remaining 50% will vest after a further 12 months of service with the Company.

A summary of the terms of the Scheme can be found in Schedule 2 and terms and conditions of the Options are set out in Schedule 4.

5.4 Shareholder Approval (Chapter 2E of the Corporations Act and Listing Rule 10.15)

Pursuant to and in accordance with the requirements of Section 219 of the Corporations Act and ASX Listing Rule 10.15, the following information is provided in relation to the proposed grant of the Options:

- (a) the maximum number of Options pursuant to the Scheme (being the nature of the financial benefit being provided) to be granted to the Related Parties is as follows:
- (i) Mr Hugh Bresser (or his nominee) – 3,925,000 Options;
 - (ii) Mr Michael Haynes (or his nominee) – 1,925,000 Options;
 - (iii) Mr Gibson Pierce (or his nominee) – 1,925,000 Options; and
 - (iv) Mr Sias Els (or his nominee) – 1,925,000 Options.
- (b) the related parties are Messrs Bresser, Haynes, Pierce and Els and they are related parties by virtue of being directors of the Company;
- (c) the Options will be issued to Messrs Bresser, Haynes, Pierce and Els (and or their nominees) for nil consideration and accordingly no funds will be raised;
- (d) the Options will be exercisable at \$0.25 each expiring on or before the date which is five (5) years from the date of issue. 50% of the Options received will vest immediately, whilst the remaining 50% will vest after a further 12 months of service with the Company;
- (e) the terms and conditions of the Scheme is set out in Schedule 2 and the terms and conditions of the Options are set out in Schedule 4;
- (f) the Scheme was approved by Shareholders at the 2010 Annual General Meeting. No options have been issued under this Scheme (since it was approved on 23 November 2010) up to the date of this Meeting;
- (g) pursuant to Listing Rule 10.14, the persons entitled to participate in the Scheme are Mr Hugh Bresser, Mr Anthony Polglase, Mr Gibson Pierce, Mr Sias Els and Mr Michael Haynes;
- (h) the Options will be issued to the Related Parties no later than 12 months after the Annual General Meeting;
- (i) the value of the Options and the pricing methodology is set out in Schedule 3;

- (j) no loan has or will be provided to the Related Parties in relation to the subsequent exercise of the Options;
- (k) the relevant interests of the Related Parties in securities of the Company (on a post-Consolidation basis) are set out below:

- (l) the remuneration and emoluments from the Company to the Related Parties for the previous financial year and the proposed remuneration and emoluments for the current financial year are set out below:

1) Mr Els was appointed on 9 August 2010.

- (m) if the Options granted to the Related Parties are exercised, a total of 9,700,000 Shares would be allotted and issued. This will increase the number of Shares on issue from 194,064,725 to 203,764,725 with the effect that the shareholding of existing Shareholders would be diluted by an aggregate of 4.7% and individual dilution rates of 1.9%, for Mr Bresser, 0.9% for Mr Haynes, 0.9% for Mr Pierce and 0.9% for Mr Els.

The market price for Shares during the term of the Options would normally determine whether or not the Options are exercised. - (o) the Board acknowledges the grant of Options to Mr Els and Mr Pierce is contrary to Recommendation 8.2 of the ASX Corporate Governance Principles and Recommendations regarding remuneration for Non Executive Directors. However, the Board considers the grant of Options

to Mr Els and Mr Pierce is reasonable in the circumstances for the reason set out below;

- (p) the primary purpose of the grant of the Options to the Related Parties is to provide a performance linked incentive component in the remuneration package for the Related Parties to motivate and reward the performance of the Related Parties in their respective roles as Directors and in particular, in respect of Messrs Haynes and Bresser for their important roles in managing the Company's mineral exploration opportunities in Canada;

- (v) in forming their recommendations, each Director considered the experience of each other Related Party, the current market price of Shares, the current market practices when determining the number of Options to be granted as well as the exercise price and expiry date of those Options; and

- (w) the Board is not aware of any other information that would be reasonably required by Shareholders to allow them to make a decision whether it is in the best interests of the Company to pass Resolutions 5 to 8.

At the request of Nick Day, Company Secretary of Overland Resources Limited ("OVR" or "the Company") received on 4 October 2011, Stantons International Securities hereby sets out our technical valuation of 9,700,000 unlisted share options ("Options") to be granted to the directors of OVR, subject to the approval of its shareholders in OVR's Annual General Meeting to be held on or around 23 November 2011. This valuation is made for the purpose of its inclusion in the notice of the general meeting; hence these Options need to be re-valued on their grant date i.e. the date of the general meeting.

In arriving at the below mentioned Options valuation, we have used the following assumptions.

1. The Black and Scholes option valuation methodology has been used. This Option Valuation methodology has been used with the expectation that the majority of these Options would be exercised towards the end of the term of these Options.
2. 9,700,000 unlisted options will be issued with an exercise price of 25 cents expiring 5 years from the date of issue being 22 November 2016.
3. The date of the valuation has been set using the closing share price of one OVR share trading on the ASX as at 4 October 2011; however the term of expiry is commencing from 23 November 2011.
4. The closing price of a listed OVR share as at the close of 4 October 2011 was 9.5 cents.
5. We have used a rate of a five year Australian Government bond as 3.59%.
6. The Options will be issued without any consideration. These Options also have vesting conditions which are not market based conditions, therefore no discount is required. We have assumed that no dividends are expected to be declared or paid by the Company during the term of the Options.
7. We note that the one year high for the Company share price leading up to 4 October 2011 was 40 cents and the one year low share price was 9.5 cents with a simple volatility of 321.05%. We note that the four months high for the Company share price was 18 cents and the four months low for the Company share price was 9.5 cents with a simple volatility of 89.47%. The annualised volatility to 4 October 2011 that was calculated using an option volatility calculator is 140%.
8. We have used the one year historical volatility to 4 October 2011 of 140%. This volatility is so high because the share price has more than doubled from 12.5 cents at 5 October 2010 up to a closing price of 38.5 cents on 1 November 2010. Although the 6 month historical volatility is only 102%, we consider the very high one year volatility appropriate because the 2011 review of operations details upgrading of mineral exploration resources, diamond drilling and advancement towards mine permitting with no disposal of ground. OVR's current

share price of 9.5 cents with 194,064,725 issued shares gives a market capitalisation of \$18,436,149 which is less than the 30 June 2011 net assets of \$35,515,670 that included \$25,774,590 of capitalised mineral exploration. At 15 September 2011, the date the audited financial report was released; the closing share price of 12.5 cents gave a market capitalisation of \$24,258,091. Combined, these factors indicate that these shares may currently be significantly undervalued making the high volatility used in valuing these options appropriate. OVR's share price is sensitive to ASX announcements. In our opinion after taking into account the above discussion, ASX announcements, the volatility calculator, and the general trend in shares of the companies in similar businesses and trading on the ASX over the past 4 and 12 months, we are of the opinion that the fair volatility factor for the purpose of valuation as at 4 October 2011 should be 140%. We have given our valuations for three levels of 140%, 80% and 100% for the purpose of the notice of the meeting.

9. The valuations noted below are not necessarily the market prices that the Options could be traded at and it is not automatically the market prices for taxation purposes. The recipients of these Options should seek their own tax advices as to the tax treatments of receiving Options in OVR and the values for taxation purpose.
10. It is common practice to discount the technical value arrived at by Binomial or Black Scholes on unlisted share options as the "market value" of an unlisted security is arguably less than a listed security. This is supported by Lonergan in his book on valuations. It is common that the discount is in the range of 20% to 50%. In our Opinion a discount of 20% is considered reasonable as the Options are not transferable at any time prior to expiry dates. However, you should seek your auditors' opinion on applying the discount.

Based on the above discussion the valuations of one OVR Option under different volatilities are as follows:
